## 2019 Ultimate Golf Fan Experience Sweepstakes OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. The following Sweepstakes (defined below) is intended for participants in the forty-eight (48) contiguous United States and Washington, D.C., only and shall be construed and evaluated according to the laws of the United States. Do not proceed in this Sweepstakes if you are not a legal U.S. resident residing in the forty-eight (48) contiguous United States or Washington D.C. Further eligibility restrictions are contained in the official rules ("Official Rules") below.

- 1. DESCRIPTION: The "2019 Ultimate Golf Fan Experience Sweepstakes" (the "Sweepstakes") begins on Tuesday, April 30, 2019 at 12:00:01 a.m. Pacific Time ("PT") and ends on Monday, May 20, 2019 at 11:59:59 a.m. PT (the "Sweepstakes Period"). The Sponsor of this Sweepstakes is Lexus, a division of Toyota Motor Sales, U.S.A., Inc., 6565 Headquarters Drive, Plano, TX 75024 ("Sponsor"). The administrator of this Sweepstakes is Creative Zing Promotion Group, LLC ("Administrator"), 2265 Lee Road, Ste 229, Winter Park, FL 32789. The Sponsor and Administrator will collectively be referred to as the ("Sweepstakes Entities"). There is one (1) prize available, as described in Section 6.
- 2. ELIGIBILITY: Sweepstakes is open only to legal United States residents residing in the forty-eight (48) contiguous United States and Washington, D.C., who are physically located and residing therein and who are at least twenty-one (21) years of age at the time of entry (each, an "Entrant"). ENTRANT, IF SELECTED AS A WINNER, MUST BE AVAILABLE FOR TRAVEL ON DATES TO BE SELECTED BY THE SPONSOR, WHICH ARE CURRENTLY CONTEMPLATED AS JUNE 13-17, 2019. Employees, owners, shareholders, officers and directors of Sweepstakes Entities, Sponsor's local dealer groups and authorized dealers/distributors and each of their respective parent companies, affiliates, divisions, subsidiaries, agents, representatives, promotion and advertising agencies together with the immediate family members and/or those living in the same household of such persons (collectively, "Household Members"), are not eligible to participate in the Sweepstakes. "Authorized Account Holder" is defined as the natural person in whose name the e-mail account was opened. HOW TO ENTER:** During the Sweepstakes Period, Entrants must go to pages.lexuscommunications.net/UGFE (the "Website") and follow the on-screen instructions to fully and accurately complete and submit the online Entry form to receive one (1) Entry into the Sweepstakes ("Entry"). All Entries must be received by 11:59:59 a.m. PT on Monday, May 20, 2019. No automatic Entries permitted for the Sweepstakes.

Limit one (1) Entry per person for the duration of the Sweepstakes. If Entries exceed the Entry limitations, the Entrant may be disqualified, at the Sponsor's sole discretion. Entries generated by a script, macro or other automated means will be disqualified. Entrants must accurately provide all of the requested information to be eligible to win. Incomplete, unreadable, or unintelligible Entries will be disqualified. ELIGIBLE ENTRANTS MUST SUBMIT THE REQUESTED ENTRY INFORMATION IN

ACCORDANCE WITH THESE OFFICIAL RULES. NO OTHER METHOD OF SUBMISSION WILL BE ACCEPTED. Participation in the Sweepstakes constitutes Entrant's understanding of, full and unconditional agreement to, and acceptance of these Official Rules. Sponsor reserves the right to disqualify any Entrant that Sponsor determines to be in violation of any term contained in these Official Rules. Sponsor's decision not to enforce a specific provision of these Official Rules does not constitute a waiver of that provision or of the Official Rules generally.

- 4. WINNER SELECTION AND NOTIFICATION: At the conclusion of the Sweepstakes Period, one (1) potential Grand Prize Winner will be selected in a random drawing conducted by the Administrator from among all eligible Entries received. The potential Grand Prize Winner will be notified on or about Tuesday, May 21, 2019 at the email address associated with the Entry. The potential Grand Prize Winner will be required to respond (as directed) to the notification within three (3) days (or a shorter time if required by exigencies) of attempted notification. The failure to respond within the stated time period may result in forfeiture of the Grand Prize and an alternate potential Grand Prize winner will be selected and contacted, time permitting. The potential Grand Prize Winner will be required to verify address, sign, and return within three (3) days of initial notification one or more forms covering eligibility, liability, advertising and (unless prohibited by law) publicity rights and such other documents as Sponsor or Administrator may require (collectively, "Prize Acceptance Forms"). GRAND PRIZE: One (1) grand prize winner ("Grand Prize Winner") will be randomly selected to receive a 5-day/4-night trip for him/herself and one (1) travel companion ("Guest"), as further described below, to attend the 2019 U.S. Open Championship®, currently scheduled to take place June 14-16, 2019 at Pebble Beach Golf Links located in Pebble Beach, California ("**U.S. Open**") which will consist of the following: (a.) round-trip economy class air transportation for the Grand Prize Winner and Guest from a major airport near Grand Prize Winner's home (as determined by Sponsor) or ground transportation, in Sponsor's sole discretion, if Grand Prize Winner lives within a 250 mile radius to Pebble Beach, California; (b.) four (4) nights' hotel accommodations at a hotel selected by the Sponsor (one room, double occupancy, room & tax only); (c.) airport transfers to/from airport and hotel in CA (if necessary); (d.) \$300 spending money, awarded in the form of a check for the Grand Prize Winner only; (e.) admission to the 2019 U.S. Open Championship® and VIP access to the Lexus Hospitality Suite for the winner and his/her Guest on June 14, 15, & 16, 2019; (f.) one (1) memorable photo with the U.S. Open Championship® Trophy; (g.) complimentary U.S. Open merchandise; (h.) the opportunity to participate in an autograph signing with Lexus Golf Ambassadors (based on availability); (i.) the opportunity to participate in various interactive golf experiences within the Lexus Performance Experience; and (j.) Lexus car service from hotel to Pebble Beach Golf Links. Approximate Retail Value ("ARV") of the Grand Prize: \$5,000.

Grand Prize travel is currently contemplated to take place June 13 – 17, 2019 and winner must agree to travel on specified dates or prize will be forfeited. Dates of departure and return are subject to change at Sponsor's sole discretion. All Grand Prize travel details are at the sole discretion of the

Sweepstakes Entities. Guest must be at least twenty-one (21) years of age and will be required to verify address and to execute a Travel Companion Release, as directed by the Administrator, prior to the Grand Prize travel departure date. Failure to return the executed Travel Companion Release within the specified time period may result in forfeiture of Grand Prize participation for Guest.

Winner hereby grants to the Sponsor and its designees the irrevocable, royalty-free right and license to use his/her photo, video, name, voice, likeness, biographical data or information, city and state of residence and Entry materials in advertising, marketing, programming, research or promotional activities, worldwide in perpetuity, and on a winner's list, if applicable, without further compensation unless prohibited by law. Winner may be asked to participate in select publicity activities, as determined at the sole discretion of the Sponsor. Sponsor is not obligated to use any of the above-mentioned information or publicity materials but may do so and may edit such information or materials, at Sweepstakes Entities' sole discretion, without further obligation or compensation. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU.

- **8. INDEMNITY:** Each Entrant (including potential Grand Prize Winner) shall indemnify, defend and hold harmless the Released Parties from and against any and all claims, damages, actions, liability, loss, injury or expense, including reasonable attorneys' fees and costs, arising out of or in connection with: (a) participation in the Sweepstakes; (b) a breach or allegation which if true would constitute a breach of any of the representations, warranties or obligations herein; and (c) acceptance, possession, grant, or use of the Grand Prize, including without limitation, personal injury, death and property damage arising therefrom.

This arbitration provision shall be deemed to be self-executing, and in the event that either party fails to appear at any properly noticed arbitration proceeding, an award may be entered against such party notwithstanding said failure to appear. In no event shall an Entrant seek or be entitled to rescission, injunctive or other equitable relief, or to enjoin or restrain the operation of this Sweepstakes.

All issues and questions concerning the construction, validity, interpretation and enforceability of this Sweepstakes, or the rights and obligations of Entrants and Sweepstakes Entities, shall be governed by, and construed in accordance with, the laws of New York State, U.S.A., without giving effect to any choice of law or conflict of law rules (whether of New York State or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than New York State.

In the event of any conflict between these Official Rules and such privacy policy, these Official Rules shall control. By entering the Sweepstakes, you grant Sponsor permission to correspond with you via email regarding the Sweepstakes, to share your email address and any other personally identifiable information with the corresponding Sweepstakes Entities or third parties for the purpose of Sweepstakes administration, communication and fulfillment or for any other purposes permitted by these Official Rules or the Privacy Policy. Sponsor will not sell, rent, transfer or otherwise disclose your personally identifiable information to any third party other than as permitted by these Official Rules or the Privacy Policy.
